RESOLUTION RESPECTFULLY REQUESTING THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)- SORSOGON, CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO)-SORSOGON CITY TO MONITOR COMPLIANCE OF PLDT DOMESTIC SUBMARINE CABLE PROJECT AREA 1 (DSCPA1) LOCATED AT BARANGAY POBLACION, BACON DISTRICT, SORSOGON CITY.

WHEREAS, the 7th City Council issued a resolution interposing no objection on the PLDT Domestic Submarine Cable Project Area 1 (DSCPA1) subject to certain conditions to wit;

1. That BFAR Sorsogon Provincial Field Office and CENRO/PENRO-DENR Sorsogon monitors compliance of the contractor especially on matter pertaining to protection of marine ecosystem in the area; and

2. That fishing activities of fisherfolks in the area shall in no case be hampered by PLDT Domestic Cable Project.

WHEREAS, herein conditions was objectively decided by the 7th City Council to be incorporated in the resolution in order to protect the general welfare of the constituents and fisherfolks in the area;

WHEREAS, foregoing premise considered, the 7th City Council deemed it necessary to pass a resolution respectfully requesting the Bureau of Fisheries and Aquatic Resources (BFAR)- Sorsogon, Community Environmental and Natural Resources Office (CENRO)-Sorsogon to monitor compliance of PLDT **DOMESTIC SUBMARINE CABLE PROJECT AREA 1 (DSCPA1) located at Barangay Poblacion, Bacon District, Sorsogon City;**
