RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, 1ST ENGINEERING DISTRICT, PROVINCE OF SORSOGON TO FAVORABLY INCLUDE THE CONSTRUCTION OF RIVER CONTROL IN BARANGAY CABARBUHAN, BACON DISTRICT, SORSOGON CITY AS AMONG THE PRIORITY MITIGATING MEASURES ALONG FLOOD PRONE AREAS.

WHEREAS, Barangay Cabarbuhan in Bacon District of Sorsogon City is identified as among the flood prone areas in the City of Sorsogon;

WHEREAS, said area is adjacent to Rangas River exposed to a possible flooding during massive rainfall;

WHEREAS, in order to protect the interest of local residents thereof, the construction of a River Control the area would at least mitigate and reduce the risk and danger of flooding;

NOW THEREFORE, on motion of **City Councilor Hilario D. Dioneda** duly seconded by **City Councilor Rebecca D. Aquino**, resolve as it is hereby resolved to respectfully request the Department of Public Works and Highways, 1st Engineering District, Province of Sorsogon to favorably include the construction of River Control in Barangay Cabarbuhan, Bacon District, Sorsogon City as among the priority mitigating measures along flood prone areas;
