RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH THE CITY ENGINEERING OFFICE TO PRIORITIZE INCLUSION OF THE CONSTRUCTION OF RIVER CONTROL IN BARANGAY CABARBUHAN, BACON DISTRICT, SORSOGON CITY AS AMONG THE CITY'S PRIORITY MITIGATING MEASURES ALONG FLOOD PRONE AREAS.

WHEREAS, in consonance with the massive infrastructure inputs initiated by the national government, local government units also implement locally identified infrastructure projects and among this includes risk reduction initiatives;

WHEREAS, Barangay Cabarbuhan is situated adjacent to Rangas River and identified as flood prone area specially when massive rainfall are experienced in the area;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution respectfully

requesting the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through the City Engineering Office to prioritize inclusion of the construction of River Control in Barangay Cabarbuhan, Bacon District, Sorsogon City as among the City's priority mitigating measures along flood prone areas;
