RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF EDUCATION AND COMMISSION ON HIGHER EDUCATION TO CONDUCT IMPACT ASSESSMENT RELATIVE TO THE IMPLEMENTATION OF K-12 AMID COVID 19 PANDEMIC.

WHEREAS, more or less five (5) years ago, the Department of Education implemented the K-12 Program with the vision of producing quality graduates and competitive labor force in the global scenario;

WHEREAS, sometime in 2020 up to present, COVID 19 Pandemic whipped disastrously among nations wherein educational system in the Philippine implemented a Blended Learning Program;

WHEREAS, given the following circumstances, there is a need to initiate an Impact Assessment of K-12 Program in relation to the COVID 19 Pandemic which until now still exist;
