**WHEREAS**, more or less five (5) years ago, the Department of Education implemented the K-12 Program with the vision of producing quality graduates and competitive labor force in the global scenario;

**WHEREAS**, sometime in 2020 up to present, COVID 19 Pandemic whipped disastrously among nations wherein educational system in the Philippine implemented a Blended Learning Program;

**WHEREAS**, given the following circumstances, there is a need to initiate an Impact Assessment of K-12 Program in relation to the COVID 19 Pandemic which until now still exist;
