**RESOLUTION URGING THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP) AND SORECO II TO ENSURE THAT NO MAINTENANCE SCHEDULE AND POWER SERVICE INTERRUPTION SHALL BE IMPLEMENTED DURING THE CELEBRATION OF CHRISTMAS AND NEW YEAR.**

**WHEREAS**, the National Grid Corporation of the Philippines (NGCP) and SORECO II schedules Maintenance and Power Service Interruption in advance for information and knowledge of electrical consumers;

**WHEREAS**, following the near coming celebration of Christmas and New Year, services of NGCP and SORECO II especially on matters relating to continuous dependable electricity supply is vital;

**WHEREAS**, for purposes of this resolution, power service interruptions which may occur during this period not sanctioned and or due to reasons beyond the control of NGCP and SORECO II is understandable;

**WHEREAS**, foregoing premise considered, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution urging the National Grid Corporation of the Philippines (NGCP) and SORECO II to ensure that No Maintenance Schedule and Power Service Interruption shall be implemented during the celebration of Christmas and New Year;
