RESOLUTION DECLARING CHRISTMAS BREAK IN THE CONDUCT OF REGULAR SESSIONS AND LEGISLATIVE HEARINGS OF THE 7TH CITY COUNCIL FROM DECEMBER 15, 2021 AND SHALL RESUME ON JANUARY 4, 2022

WHEREAS, Christmas is an annual festival commemorating the birth of Jesus Christ, observed primarily on December 25 as a religious and cultural celebration among billions of people around the world;

WHEREAS, the yearlong performance and dedicated service of the 7th City Council and all its staffs and secretariat should be recognized and shall be provided with the opportunity to joyfully experience the spirit of the holiday season;

WHEREAS, throughout the year, the 7th City Council has recorded 43 Regular Sessions and 3 Special Sessions and thereby promulgated at least 437 Resolutions, 27 regular Ordinances, 25 Appropriation Ordinances and 132 Committee Reports;

WHEREAS, foregoing premises considered, the 7th City Council deemed it proper to declare Christmas break in the conduct of regular sessions and legislative hearings of the 7th city council from December 15, 2021 and shall resume on January 4, 2022, however, as agreed upon, the council and the secretariat shall be available at any time during the said period for the conduct of special sessions as the need arises;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by the body, resolved as it is hereby resolve to declare Christmas break in the conduct of regular sessions and legislative hearings of the 7th city council from December 15, 2021 and shall resume on January 4, 2022.
