**RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 2021-01 FROM  
THE BARANGAY COUNCIL OF BARANGAY PIOT, WEST DISTRICT, SORSOGON  
CITY ENTITLED “AN ORDINANCE AUTHORIZING THE CITY OF SORSOGON TO  
ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY  
CLEARANCE FEES IN THE APPLICATION FOR ANY BUSINESS RELATED  
TRANSACTION SUBJECT TO THE REMITTANCE OF THE COLLECTION THEREFOR  
TO THE BARANGAY AND OTHER CONDITIONS HEREUNDER”**

**WHEREAS, Barangay Ordinance No. 2021-01 from the Barangay Council of Barangay Piot,  
West District, Sorsogon City was among the items deliberated upon by the 7<sup>th</sup> City Council during  
the December 14, 2021 Regular Session;**

**WHEREAS**, cursory reading of the submitted barangay ordinance reveals that the said barangay ordinance is within the ambits of the powers conferred to the barangay council by virtue of Chapter 4, Section 391 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

**WHEREAS**, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 2021-01 from the Barangay Council of Barangay Piot, West District, Sorsogon City entitled "An ordinance authorizing the City of Sorsogon to issue barangay clearance and collect corresponding barangay clearance fees in the application for any business related transaction subject to the remittance of the collection therefor to the barangay and other conditions hereunder";

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Franco Eric O.
