CONTRACT AGREEMENT

THIS AGREEMENT made this 18th day of March , 20222 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MA. ELENA T. MORADA proprietor of 38MJ ENTERPRISES (hereinafter called the "Supplier") of the other part:

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation; (a_1, b_2)

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

REGENCE Of the contract documents that may be required by existing laws and/or the REGENCE Additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

> In consideration for the sum of Seventy One Thousand Six Hundred Seventy Nine Pesos (Php 71,679.00) Only or such other sums as may be ascertained, 38MJ ENTERPRISES_ agrees to viz SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES FOR THE CITY GENERAL SERVICES OFFICE in accordance with his/her/its Bid.

4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
