RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE DONATION OF THE PHILIPPINE RICE RESEARCH INSTITUTE (PhilRice – Bicol) REPRESENTED BY ITS BRANCH DIRECTOR, VICTORIA C. LAPITAN TO THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, among the items deliberated during the May 24, 2022 Regular Session of the 7th City Council is the Transmittal No. 29, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated May 4, 2022 requesting for the passage of a Resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the Donation of the Philippine Rice Research Institute (Philrice – Bicol) represented by its Branch Director, Victoria C. Lapitan to the City Government of Sorsogon;

WHEREAS, PhilRice – Bicol is mandated to implement the development, propagation and promotion of inbred rice quality seeds under the Rice Competitiveness Enhancement Fund (RCEF), in particular, provide certified inbred seeds to help improve the competitiveness of the Filipino rice farmers, increase their income and sustain the resilience and responsiveness of the rice industry;

WHEREAS, the LGU Sorsogon City, thru its Municipal Social Welfare Development Office (MSWDO) is mandated to address poverty-related concerns and implement different social welfare and development programs such as relief operations and feeding programs, and is committed to the care, protection and rehabilitation of individuals, families, groups and communities;

WHEREAS, the Philippine Rice Research Institute (PhilRice – Bicol) shall be donating Seven Hundred Fifty Three (753) bags of seeds that are no longer suitable for planting to the City Government of Sorsogon;

WHEREAS, the seeds shall be received by the LGU thru its Social Welfare and Development Office and milled in order for the same to be used for purposes beneficial to the residents of the City of Sorsogon;

WHEREAS, attached to the letter is a copy of a draft Deed of Donation for further perusal of the 7th City Council;

NOW THEREFORE, on incidental motion of **Hon. Fernando David H. Duran, III**, duly seconded by **Hon. Nestor J. Baldon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to accept the Donation of the Philippine Rice Research Institute (Philrice – Bicol) represented by its Branch Director, Victoria C. Lapitan to the City Government of Sorsogon;
