RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE REGIONAL OFFICES OF THE OFFICE OF CIVIL DEFENSE (OCD) REPRESENTED BY ITS REGIONAL DIRECTOR, BGEN CLAUDIO L. YUCOT, AFP (RET), DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS OIC-REGIONAL DIRECTOR, LEO L. QUINTILLA, CESE, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) REPRESENTED BY ITS REGIONAL DIRECTOR, VIRGILIO C. EDUARTE, CESO IV AND DEPARTMENT OF HEALTH (DOH) REPRESENTED BY ITS REGIONAL DIRECTOR, ERNIE V. VERA, MD, MPh, CHA, CESO III, RELATIVE TO THE ESTABLISHMENT, OPERATION AND TURNOVER OF THE DPWH EVACUATION CENTER PROJECT AT BACON DISTRICT, SORSOGON CITY.

WHEREAS, among the items deliberated during the May 24, 2022 Regular Session of the 7<sup>th</sup> City Council is the Transmittal No. 26, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated May 4, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Regional Offices of the Office of Civil Defense (OCD) represented by its Regional Director, BGen Claudio L. Yucot, AFP (Ret), Department of Social Welfare and Development (DSWD) represented by its OIC-Regional Director, Leo L. Quintilla, CESE, Department of Public Works and Highways (DPWH) represented by its Regional Director, Virgilio C. Eduarte, CESO IV and Department of Health (DOH) represented by its Regional Director, Ernie V. Vera, MD, MPh, CHA, CESO III, relative to the establishment, operation and turnover of the DPWH Evacuation Center Project at Bacon District, Sorsogon City;

**WHEREAS**, on May 27, 2010, Republic Act 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, was passed into law and this Act aims to strengthen the country's disaster risk reduction and management system;

WHEREAS, one of the policies of the State under Republic Act No. 10121 is to mainstream disaster risk reduction and climate change in development processes such as policy formulation, socioeconomic development planning, budgeting and governance, particularly in the areas of environment agriculture, water, energy, health, education, poverty reduction, land-use and urban planning, and public infrastructure and housing, among others;

**WHEREAS,** the government intends to prevent the use of schools and its facilities as evacuation areas in times of disasters, which results to the displacement of the students of their learning centers;

**WHEREAS,** the government recognizes and wants to strengthen the capacities of the local government units and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

**WHEREAS,** the Regional Disaster Risk Reduction and Management Council (RDRRMC) has identified thirty-one (31) LGUs in Region V where the Evacuation Center Projects are to be implemented;

**WHEREAS,** the Local Government Unit of Bacon District, Sorsogon is one of the identified LGUs with Poblacion, Bacon District, Sorsogon as the site/location of the Evacuation Center Project;

WHEREAS, the funding for the construction of the Evacuation Center in Poblacion, Bacon District, Sorsogon is Thirty Seven Million Pesos (Php37,000,000.00), charged against the Regular Agency Fund, FY 2019 General Appropriations Act, RA 11260, National Disaster Risk Reduction and Management Fund (NDRRMF) (Calamity Fund);

**WHEREAS,** the DPWH is the engineering and construction arm of the government responsible for the planning, design, construction and maintenance of infrastructure, especially the national highways, flood control and water resources development system, and other public works in accordance with national development objectives;

**WHEREAS,** the DPWH – ROV is the implementing office for the construction of the thirty-one (31) NDRRM Funded Evacuation Centers;

WHEREAS, the DSWD as cluster lead of the Camp Coordination and Camp Management, as stated in the National Disaster Response Plan, aims to provide timely and well-coordinated

humanitarian assistance and augmentation support in the management of the evacuation center:

WHEREAS, the DOH as stated in the National Disaster Response Plan, led clusters composed of the Medical and Public Health, Mental Health and Psycho-Social Support (MHPSS), Nutrition and WASH sub-clusters of the DOH – Health Emergency Management System (HEMS) aims to provide support for a timely and appropriate public health services to the affected population:

**WHEREAS**, attached to the letter is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 7<sup>th</sup> City Council;

NOW THEREFORE, on incidental motion of Hon. Fernando David H. Duran, III, duly seconded by **Hon. Franco Eric O. Ravanilla** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Regional Offices of the Office of Civil Defense (OCD) represented by its Regional Director, BGen Claudio L. Yucot, AFP (Ret), Department of Social Welfare and Development (DSWD) represented by its OIC-Regional Director, Leo L. Quintilla, CESE, Department of Public Works and Highways (DPWH) represented by its Regional Director, Virgilio C. Eduarte, CESO IV and Department of Health (DOH) represented by its Regional Director, Ernie V. Vera, MD, MPh, CHA, CESO III, relative to the establishment, operation and turnover of the DPWH Evacuation Center Project at Bacon District, Sorsogon City;

**RESOLVED FURTHER**, that the Memorandum of Agreement (MOA) entered into by the parties shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;
