RESOLUTION COMMENDING THE COMMISSION ON ELECTIONS (COMELEC), PHILIPPINE NATIONAL POLICE (PNP), PARISH PASTORAL COUNCIL FOR RESPONSIBLE VOTING (PPCRV), TEACHER/MEMBERS OF THE BOARD OF ELECTION INSPECTORS, VOLUNTEERS, BARANGAY OFFICIALS OF THE 64 BARANGAYS OF THE CITY OF SORSOGON AND THROUGHOUT THE PROVINCE IN THE ACTIVE PARTICIPATION DURING THE CONDUCT OF HONEST, PEACEFUL AND SUCCESSFUL LOCAL AND NATIONAL ELECTIONS HELD LAST MAY 9, 2022.

**WHEREAS**, one of the specific powers and functions of the Commission on Elections (COMELEC) is to enforce and administer all laws and regulations relative to the conduct of an election, plebiscite, initiative, referendum and recall;

**WHEREAS**, the Parish Pastoral Council for Responsible Voting (PPCRV) is a non-partisan, non-sectarian, non-profit organization affiliated with the Roman Catholic Church in the Philippines that works to ensure free, fair, and fraud-free elections in the Philippines;

**WHEREAS**, the Local Government Code of the Philippines mandates all barangay officials to support national activities such as local and national elections;

**WHEREAS,** that while all barangay officials are mandated to actively participate in the conduct of honest and peaceful election, they are apolitical in nature;

**WHEREAS**, as observed during the last election that while there are isolated incidents of disturbances in the recent election, it has been observed in the Province of Sorsogon that it is generally peaceful and successful due to the support of PNP- Sorsogon City and Province, Barangay Officials, PPCRV, Teachers and Volunteers;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution commending the Commission On Elections (COMELEC), Philippine National Police (PNP), Parish Pastoral Council For Responsible Voting (PPCRV), Teacher/Members of the Board of Election Inspectors, Volunteers, Barangay Officials of the 64 Barangays of the City of Sorsogon and throughout the Province in the active participation during the conduct of Honest, Peaceful and Successful Local and National Election held last May 9, 2022.
