RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF ENCONTRADA SPONSORED BY THE BARANGAY COUNCIL OF BUCALBUCALAN SCHEDULED ON JUNE 7, 8, & 9, 2022 AT THE GUINLAJON COCKPIT COLISEUM, BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the May 24, 2022 Regular Session of the 7th City Council was the request for a passage of a resolution authorizing and approving the conduct of *encontrada* sponsored by the Barangay Council of Bucalbucalan, West District, Sorsogon City scheduled on June 7, 8 & 9, 2022 at the Guinlajon Cockpit Coliseum, Barangay Guinlajon West District, Sorsogon City;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement

through the owner of the cockpit and shall be given to the respective requesting party and that the party shall faithfully comply therewith;

WHEREAS, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of *encontrada* sponsored by the Barangay Council of Bucalbucalan, West District, Sorsogon City scheduled on June 7, 8 & 9, 2022 at the Guinlajon Cockpit Coliseum, Barangay Guinlajon West District, Sorsogon City;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to approve and authorize the conduct of *encontrada* sponsored by the Barangay Council of Bucalbucalan, West District, Sorsogon City scheduled on June 7, 8, & 9, 2022 at the Guinlajon Cockpit Coliseum, Brgy. Guinlajon, West District, Sorsogon City;
