RESOLUTION ENDORSING TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) REGIONAL OFFICE V FOR FUNDING UNDER THE ANNUAL BUDGET/SUCCEEDING YEARS INTENDED FOR THE CONSTRUCTION OF A BRIDGE AT SITIO TAGALWOY, BARANGAY GATBO, SORSOGON CITY

**WHEREAS**, the Sangguniang Panlungsod has passed Resolution No. 377, Series of 2021 requesting the Department of Public Works and Highways (DPWH) to allocate funds for the construction of a bridge at Sitio Tagalwoy, Barangay Gatbo, Sorsogon City;

**WHEREAS**, a Memorandum issued by Engr. Virgilio C. Eduarte, CESO IV, Regional Director of DPWH-Region V, required Engr. Merla A. Reveche, OIC-District Engineer, Sorsogon 1<sup>st</sup> District Engineering Office, to assess/evaluate the project in coordination with the city government of Sorsogon;

**WHEREAS**, the Memorandum further instruct the Sorsogon 1<sup>st</sup> District Engineering Office to prepare the necessary documents as required for the new bridge construction;

**WHEREAS,** the Memorandum likewise required to secure the endorsement of the Sangguniang Panlungsod for the said undertaking, hence this resolution was formally approved for the purpose;
