RESOLUTION RESPECTFULLY APPEALING P/MAJ. GEN. ANTONIO N. GARDIOLA, JR. (RET.), REGIONAL DIRECTOR, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD, REGIONAL OFFICE V AND ATTY. ANTHONY C. NUYDA, CESO III, REGIONAL DIRECTOR, DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, REGIONAL OFFICE V TO ACCEPT AND ACCOMMODATE SUBMISSION OF DOCUMENTARY REQUIREMENTS OF REGISTERED TRICYCLE DRIVERS FOR PURPOSES OF AVAILMENT OF PANTAWID PASADA PROGRAM (FUEL SUBSIDY PROGRAM).

WHEREAS, as part of the national government's effort to uplift economic situation among public transport sector which is among the most vulnerable groups following the unprecedented oil increases in the world market due to the on-going Russia-Ukraine conflict, the Land Transportation Franchising Regulatory Board (LTFRB) and the Department of the Interior

and Local Government (DILG) were tasked to implement the Pantawid Pasada Program (Fuel Subsidy Program) for Registered Tricycle Drivers in local government units;

WHEREAS, at the shortest notice, the City Government of Sorsogon cooperated in the aforementioned endeavour, however, there are still remaining Registered Tricycle Drivers who submits documentary requirements after the deadline set by the Department of the Interior and Local Government (DILG);

WHEREAS, following the "Principle of Consideration", the 7th City Council thus respectfully appeal to P/Maj. GEN. ANTONIO N. GARDIOLA, JR. (RET.), Regional Director, Land Transportation Franchising Regulatory Board, Regional Office V and Atty. ANTHONY C. NUYDA, CESO III, Regional Director, Department of the Interior and Local Government, Regional Office V to accept and accommodate submission of documentary requirements of Registered Tricycle Drivers for purposes of availment of Pantawid Pasada Program (Fuel Subsidy Program);
