**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF DERBY AND ENCONTRADA AT THE AUTHORIZED COCKPIT ARENA/COLISEUM IN SUPPORT AND IN CONNECTION WITH THE CELEBRATION OF BARANGAY FIESTA IN FAVOR OF INTERESTED BARANGAYS IN THE CITY OF SORSOGON**

**WHEREAS**, among the items deliberated during the May 24, 2022 Regular Session of the 7th City Council was the passage of a resolution authorizing and approving the conduct of derby and encontrada at the authorized cockpit arena/coliseum in support and in connection with the celebration of Barangay Fiesta in favor of interested barangays in the City of Sorsogon;

**WHEREAS**, cockfighting has been and still is a popular, traditional and customary form of recreation and entertainment among Filipinos during legal holidays, local fiestas, agricultural, commercial and industrial fairs, carnivals or expositions and cockfighting activities serve as a

driving tool in the preservation and perpetuation of native Filipino heritage, thus, enhancing the national identity;

**WHEREAS**, as per consensus, a certain amount of the total share of the requesting party from the derby and or *encontrada* shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective requesting party and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing and approving the conduct of derby and *encontrada* at the authorized cockpit arena/coliseum in support and in connection with the celebration of Barangay Fiesta in favor of interested barangays in the City of Sorsogon;

**NOW THEREFORE**, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to approve and authorize the authorizing and approving the conduct of derby and *encontrada* at the authorized cockpit arena/coliseum in support and in connection with the celebration of Barangay Fiesta in favor of interested barangays in the City of Sorsogon;

**RESOLVED FURTHER**, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;

**RESOLVED FINALLY**, that copies of this resolution be furnished to all concerned for their information and guidance.
