

## CONTRACT AGREEMENT

THIS AGREEMENT made this 14th day of January , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and DENNIS B. DURAN Jr. proprietor of AUTO-MOTO ZONE ENTERPRISES (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF ADDITIONAL SPAREPARTS** FOR THE DIFF. CITY GOV'T VEHICLE FOR THE MONTH OF JANUARY 2022 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum *Seventy Eight Thousand Two Hundred Fifteen Pesos (P 78,215.00) Only* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of Pesos (P 78,215.00) Only or such other sums as may be ascertained, AUTO-MOTO ZONE ENTERPRISES\_ agrees to viz PROCUREMENT OF ADDITIONAL SPAREPARTS FOR THE DIFF. CITY GOV'T VEHICLE FOR THE MONTH OF JANUARY 2022 in accordance with his/her/its Bid.

4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
