CONTRACT AGREEMENT

THIS AGREEMENT made this 1st day of April, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and PAUL DESCALLAR DINO Proprietor of RMM CATERING SERVICES (hereinafter called the "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *Eighty Four Thousand Pesos (P 84,000.00)* or such other sums as may be ascertained, *RMM CATERING SERVICES* agrees to viz *PROCUREMENT OF CATERING SERVICES FOR THE CSE-PPT REVIEW OF EMPLOYEES OF THE CITY GOV'T* in accordance with his/her/its Bid. 4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
