CONTRACT AGREEMENT

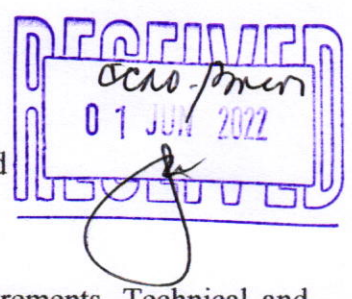
THIS AGREEMENT made this **23rd** day of **May**, **2022** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **JAYRO J. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

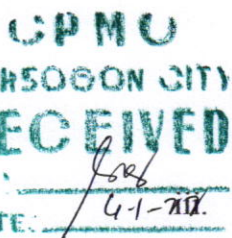
1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

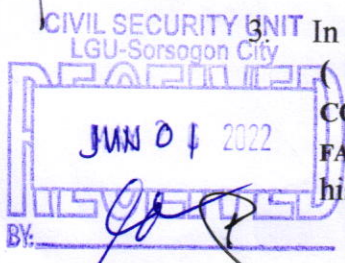

- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



In consideration for the sum of **Eighty Nine Thousand Eight Hundred Pesos (Php 89,800.00) Only** or such other sums as may be ascertained, **JAYRO CONSTRUCTION & SUPPLY** agrees to viz **PROCUREMENT OF MATERIALS FOR THE FABRICATION/INSTALLATION OF LABORATORY CABINET** in accordance with his/her/its Bid.
