

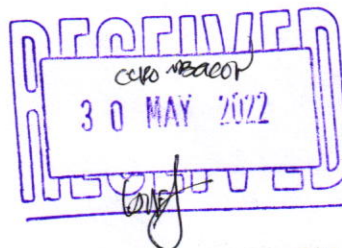

CONTRACT AGREEMENT

THIS AGREEMENT made this 23rd day of December, 2021 between **Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines** (hereafter called the "entity") of the one part and **JAYRO J. LABASBAS proprietor JAYRO CONSTRUCTION & SUPPLY** (hereafter called the "supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF MATERIALS FOR THE REPAIR AND IMPROVEMENT OF MASSAGE PARLOR** and has accepted a bid by the Supplier for the supply of those goods and services in the sum *Two Hundred Fifty Seven Thousand One Hundred Seventy Four & 75/100 Pesos (Php 257,174.75) Only* (hereafter called the "Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In his Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical an Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the procuring Entity's bid evaluation;

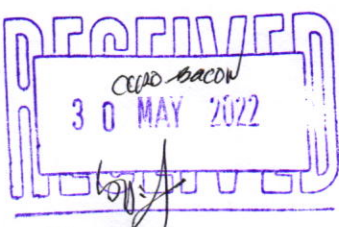
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

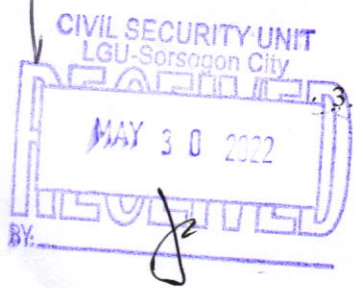
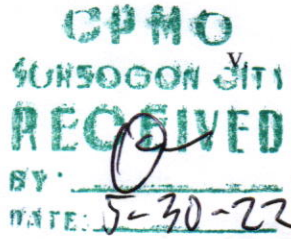
