



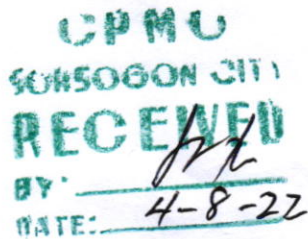

CONTRACT AGREEMENT

THIS AGREEMENT made this **25th** day of **March, 2022** between **Ma. Ester E. Hamor, City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **PAUL DESCALLAR DINO** Proprietor of **RMM CATERING SERVICES** (hereinafter called the "Supplier") of the other part:

WITNESS

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation,

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Hundred Three Thousand Five Hundred Only (₱ 103,500.00)** or such other sums as may be ascertained, **RMM CATERING SERVICES** agrees to viz **PROCUREMENT OF CATERING SERVICES FOR THE MENTAL HEALTH SEMINAR OF SULAY SA FUTURO (CITY SCHOLAR)** in accordance with his/her/its Bid.






