### CONTRACT AGREEMENT

THIS AGREEMENT made this **23rd** day of **May , 2022** between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines ( hereinafter called the " Entity" ) of the one part and **LEO HABAL HILIS** proprietor of **RBMPRO ELITE SOUNDS SYSTEM RENTAL** ( hereinafter called the "Supplier" ) of the other part:

  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation.

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conformance thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Eighty Thousand Pesos ( ₱ 80,000.00 ) Only** or such other sums as may be ascertained, **RBMPRO ELITE SOUNDS SYSTEM RENTAL** agrees to **RENTAL OF LIGHTS AND SOUNDS WITH LED WALL FOR THE BEER PLAZA @ CARICARAN** in accordance with his/her/its Bid.


