### CONTRACT AGREEMENT

THIS AGREEMENT made this 23rd day of June , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and ARIEL L. AQUINO proprietor of A.L. AQUINO FIREWORKS (hereinafter called the "Supplier") of the other part:

    - Schedule of Requirements; i.
    - Technical Specifications; ii.
    - General and Special Conditions of Contract; and iii.
      - Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and ancial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the V. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of Five Hundred Thousand (P 500,000.00) Pesos or such other sums as may be ascertained, A.L. AQUINO FIREWORKS agrees Only to the PROCUEMENT OF FIREWORKS FOR THE FIRE WORKS DISPLAY DURING THE FESTIVAL in accordance with his/her/its Bid.

4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
