RESOLUTION ENACTING AN ORDINANCE AUTHORIZING THE GRANT OF MID YEAR BONUS AND OTHER PERSONNEL BENEFITS TO CITY OFFICIALS AND EMPLOYEES PURSUANT TO EXECUTIVE ORDER NO. 201 ISSUED BY THE OFFICE OF THE PRESIDENT AND LOCAL BUDGET CIRCULAR NO. 108, SERIES OF 2016 ISSUED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT.

WHEREAS, in consonance with personnel development, the Office of the President issued Executive Order No. 201 stipulating therein the scheme for salary increase for government workers;

WHEREAS, for purposes of clarification on the implementation of the aforementioned endeavor, the Department of Budget and Management issued Local Budget Circular No. 108, series of 2016 which shall be the basis for the computation of salary increase and grant of other benefits;

WHEREAS, for purposes of speedy disposition of the same, the 5th City Council requested the presence of Ms. Merly Diaz, City Budget Officer in order to clarify issues and to pass legislation if any in support or as a requirement for the immediate release of the same to City Officials and Employees;

WHEREAS, foregoing premise considered, the 5th City Council deemed it necessary to pass an ordinance authorizing the grant of Mid Year Bonus and other Personnel Benefits to City Officials and Employees pursuant to Executive Order No. 201 issued by the Office of the President and Local Budget Circular No. 108, Series of 2016 issued by the Department of Budget and Management;

NOW THEREFORE, on motion of Hon. Iñigo D. Destacamento, duly seconded by the Hon. Ralph Walter R. Lubiano, resolve as it is hereby done to enact an ordinance authorizing the grant of Mid Year Bonus and other Personnel Benefits to City Officials and Employees pursuant to Executive Order No. 201 issued by the Office of the President and Local Budget Circular No. 108, Series of 2016 issued by the Department of Budget and Management.

BE IT ORDAINED BY THE 5TH CITY COUNCIL IN SESSION ASSEMBLED THAT:

SECTION 1. SOURCE OF FUNDS.

The Source of funds for the implementation of this endeavor shall be charged against Non-Office under Other Personnel Benefits.

SECTION. ISSUANCE OF NOTICE OF SALARY ADJUSTMENT.

In relation to the preceding section, the City Human Resource Management Office shall closely coordinate with the City Budget Office and shall prepare Notice of Salary Adjustments to City Officials and Employees.

SECTION 3. EFFECTIVITY.

This ordinance shall take effect immediately upon its approval.
