RESOLUTION ENACTING AN ORDINANCE NAMING THE STAND ALONE SENIOR HIGH SCHOOL AT BRGY. SUGOD, BACON DISTRICT, SORSOGON CITY AS SUGOD SENIOR HIGH SCHOOL.

WHEREAS, the Local Barangay Government of Sugod whose commitment to public education for the youth people of the barangay by providing good and healthy environment conducive to learning passed a resolution donating a Three Thousand (3,000) square meters lot to the Department of Education, Sorsogon City Division intended for senior high school students in the area and its neighboring vicinity;

WHEREAS, Lydia D. Martinez Memorial High School which is implementing a Senior High School Program this coming school year was a recipient of a Two (2) six-room school building from the DepEd Building Program that will cater and accommodate the fast increasing enrolment of high school students from Barangay Sugod and its adjacent barangay and will decongest the present campuses;

WHEREAS, Section 13 (c) (3) and (e) of the Local Government Code states that "The Sanggunians of component cities and municipalities may, in consultation with the Historical Commission, change the name of the following within its territorial jurisdiction..." (c) Public elementary, secondary and vocational or technical schools, community colleges and non-chartered colleges; and (e) A change of name of public school shall be made only upon the recommendation of the local school board;

WHEREAS, Local School Board Resolution No. 04, Series of 2016 recommended for the passage of a city ordinance for this purpose;

WHEREAS, foregoing premises considered, the 6th City Council deemed it necessary to pass a resolution enacting an ordinance naming the Stand Alone Senior High School at Brgy. Sugod, Bacon District, Sorsogon City as **Sugod Senior High School**.

NOW THEREFORE, on motion of the **Hon. Iñigo D. Destacamento**, duly seconded by **City Councilor Hilario D. Divina**, resolve as it is hereby resolved to enact:

Oity Ordinance No. 010, Series of 2016

AN ORDINANCE NAMING THE STAND ALONE SENIOR HIGH SCHOOL AT BRGY. SUGOD, BACON DISTRICT, SORSOGON CITY AS SUGOD SENIOR HIGH SCHOOL

Be it ordained by the 6th Sangguniang Panlungsod of Sorsogon City in session that:

SECTION 1 COVERAGE

This ordinance shall cover the naming of the newly constructed school located at Barangay Sugod, Bacon District, Sorsogon City on the lot donated by Local Barangay Government of Sugod to the Department of Education, Sorsogon City.

SECTION 2 NAMING OF SCHOOL

The newly constructed Senior High School shall be named as **Sugod Senior High School.**

SECTION 3 SCHOOL CATEGORY

For this purpose, the new school will cater and accommodate the Senior High School of Barangay Sugod and the adjacent barangays of Bacon District, Sorsogon City;

SECTION 4 REPEALING CLAUSE

All ordinances, resolutions, rules and regulations, or any part(s) thereof which are inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

SECTION 5 SEPARABILITY CLAUSE

If any reason or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6 EFFECTIVITY

This ordinance shall take effect immediately upon its approval by the Sangguniang Panlungsod and after compliance with the law on public dissemination and publication.
