**RESOLUTION ENACTING AN ORDINANCE NAMING THE NEW ELEMENTARY SCHOOL  
LOCATED AT SITIO BANCAL, BARANGAY SAN ROQUE, BACON DISTRICT, SORSOGON CITY  
AS ANASTACIO CASTANEDA ESCARO ELEMENTARY SCHOOL.**

**WHEREAS**, there is a resolution passed by Hon. Hilario D. Dioneda supporting the establishment of an elementary school located at Sitio Bancal, Brgy. San Roque, Bacon District, Sorsogon City;

**WHEREAS**, a parcel of land with a total land area of *Eight Thousand One Hundred (8,100) square meters* located at Sitio Bancal, Brgy. San Roque, Bacon District was donated by the heir Ms. Teresita Escaro to the Department of Education, Sorsogon City Division intended for the people in the area and its neighbouring vicinity to commensurate a more healthy-environment, conducive to learning elementary education;

**WHEREAS**, her endeavour is in honor and memory of her late father, Anastacio Castaneda Escaro whose commitment to a quality education among elementary pupils as a foundation to learning;

**WHEREAS**, Section 13 (c) (3) and (e) of the Local Government Code states that “The Sanggunians of component cities and municipalities may, in consultation with the Historical Commission, change the name of the following within its territorial jurisdiction...” (c) Public elementary, secondary and vocational or technical schools, community colleges and non-chartered colleges; and (e) A change of name of public school shall be made only upon the recommendation of the local school board;

**WHEREAS**, Local School Board Resolution No. 03, Series of 2016 recommended for the passage of a city ordinance for this purpose;

**WHEREAS**, foregoing premises considered, the 6<sup>th</sup> City Council deemed it necessary to pass a resolution enacting an ordinance naming the new Elementary School located at Sitio Bancal, Brgy. San Roque, Bacon District, Sorsogon City as **Anastacio Castaneda Escaro Elementary School**.

**NOW THEREFORE**, on motion of the **Hon. Iñigo D. Destacamento**, duly seconded by **City Councilor Florencio J. Jamisola, Jr.**, resolve, as it is hereby resolved to enact:

## *City Ordinance No. 011, Series of 2016*

**AN ORDINANCE NAMING THE NEW ELEMENTARY SCHOOL AT SITIO BANCAL, BRGY. SAN ROQUE, BACON DISTRICT, SORSOGON CITY AS ANASTACIO CASTANEDA ESCARO ELEMENTARY SCHOOL**

Be it ordained by the 6<sup>th</sup> Sangguniang Panlungsod of Sorsogon City in session that:

### **SECTION 1    COVERAGE**

This ordinance shall cover the naming of the newly established elementary school located at Sitio Bancal, Barangay San Roque, Bacon District, Sorsogon City on the lot donated by Ms. Teresita Escaro to the Department of Education Sorsogon City.

### **SECTION 2    NAMING OF SCHOOL**

The newly established elementary school shall be named as **ANASTACIO CASTANEDA ESCARO ELEMENTARY SCHOOL** in honour and memory of donor’s late father **ANASTACIO CASTANEDA ESCARO**.

### **SECTION 3    SCHOOL CATEGORY**

For this purpose, the new school will cater and accommodate the elementary curriculum for public elementary students in the area and its adjacent barangays of the Bacon District of Sorsogon City;

### **SECTION 4    REPEALING CLAUSE**

All ordinances, resolutions, rules and regulations, or any part(s) thereof which are inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

**SECTION 5 SEPARABILITY CLAUSE**


If any reason or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 6 EFFECTIVITY**

This ordinance shall take effect immediately upon its approval by the Sangguniang Panlungsod and after compliance with the law on public dissemination and publication.
