## CONTRACT AGREEMENT

THIS AGREEMENT made this **8th** day of **April**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and **RHEA J. OLAYRES** proprietor of **BRYSAM ENTERPRISES** ( hereinafter called the "Supplier" ) of the other part:

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

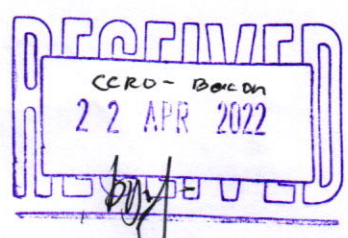
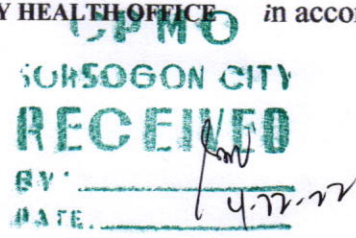
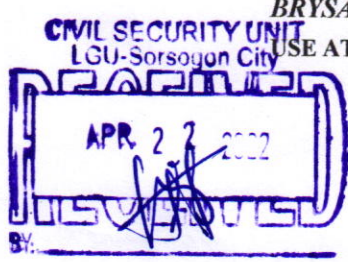
- iii. Performance Security;

3. In consideration for the sum of **Three Hundred Twenty Nine Thousand Five Hundred Fifty Pesos (P 329,550.00)** or such other sums as may be ascertained, **BRYSAM ENTERPRISES** agrees to the **PRINTING OF COVID RELATED FORMS FOR USE AT CITY HEALTH OFFICE** in accordance with his/her/its Bid.


