### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 5th day of August, 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MILAGROS D. LIAO proprietor of BIG BENTERPRISES (hereinafter called the "Supplier") of the other part:
