RESOLUTION MOST RESPECTFULLY REQUESTING THE SORSOGON CITY WATER DISTRICT AND PRIME WATER INFRASTRUCTURE INC. TO ALLOW THE CITY **ENGINEERING OFFICE TO CONDUCT SERIES OF INSPECTION ALONG WITH ITS** TEAM AND PROVIDE REPORT CORRESPONDING TO THEIR FINDINGS AND **RCOMMENDATIONS IN RELATION THERETO**

WHEREAS, Sorsogon City Water District (SCWD), the water provider for Sorsogon City, entered into a Joint Venture Agreement with Prime Water Infrastructure, Inc.;

WHEREAS, through this Joint Venture Agreement, the Prime Water-Sorsogon City started its operations on October 17, 2016;

WHEREAS, the Sorsogon City Water District and Prime Water-Sorsogon City committed to uphold the highest standard of public service consistent with its mandate as a public utility to deliver safe, potable, adequate and affordable water to the consuming public of Sorsogon City;

WHEREAS, the constituents of Sorsogon City are primarily dependent on the services of Prime Water-Sorsogon City as their main water source and as paying consumers deserve safe, potable, sufficient and adequate water supply;

WHEREAS, the consumers are continuously experiencing very low water supply to no water supply with water discoloration from Prime Water-Sorsogon City;

WHEREAS, such bad nature of service is documented by the Commission on Audit in its Annual Audit Reports on Sorsogon City Water District (SCWD);

WHEREAS, premises considered, the City Government of Sorsogon is constrained to conduct its own inspection and submit findings, conclusions and recommendations for the benefit of the general public;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to respectfully request the Sorsogon City Water District and Prime Water Infrastructure Inc. to allow the City Engineering Office to conduct series of inspection along with its team and provide report corresponding to their findings and recommendations In relation thereto
