RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A CONTRACT WITH THE WINNING CONTRACTOR FOR THE PROJECT SWINE BREEDER AND PRODUCTION FARM LIVELIHOOD ASSISTANT THROUGH ARTIFICIAL INSEMINATION FOR SWINE AT BACON DISTRICT, SORSOGON CITY.

WHEREAS, among the items deliberated during the July 05, 2022 Regular Session of the 8th City Council is the Transmittal No. 38, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated June 22, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Contract with the winning contractor, for the project Swine Breeder and Production Farm Livelihood Assistant through Artificial Insemination for Swine at Bacon District, Sorsogon City;
