**RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION OF MR. VIRGILIO Y. DEALCA, PROPRIETOR, VYD GAS STATION TO OPERATE A PORTABLE GAS REFILLING MACHINE AT BARANGAY SAN ROQUE, BACON DISTRICT, SORSOGON CITY.**

**WHEREAS**, records from the Office of the secretary to the Sangguniang Panlungsod revealed that Mr. Virgilio Y. Dealca, Proprietor, VYD Gas Station has a pending request filed before the Sangguniang Panlungsod seeking for the passage of a resolution interposing no objection on his proposed business endeavor;

**WHEREAS**, during committee hearing conducted by the the Committee on Public Order and Safety, the applicant was instructed to comply with mandatory requirements imposed by appropriate local and national government agencies;

**WHEREAS**, in consonance with the principle of free trade and in order to protect the interest of the general constituents against the dangers of “bote-bote system” of selling of

petroleum products, the 8<sup>th</sup> City Council, through the Chairman's Committee Report of the Committee on Public Order and Safety of the 7<sup>th</sup> City Council, hereby adopts and approves the recommendation for the passage of a resolution interposing no objection for the aforementioned application;
