RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE STATISTICS AUTHORITY (PSA) REPRESENTED BY ITS REGIONAL DIRECTOR, MS. CYNTHIA L. PERDIZ, DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. ANTHONY C. NUYDA, CESO III, AND PROVINCIAL GOVERNMENT OF SORSOGON REPRESENTED BY ITS GOVERNOR, HON. JOSE EDWIN B. HAMOR, RELATIVE TO THE COLLABORATION OF THE PARTIES IN RELATION TO THE CONDUCT OF COMMUNITY-BASED MONITORING SYSTEM (CBMS).

WHEREAS, among the items deliberated during the July 12, 2022 Regular Session of the 8th City Council is the Committee Report No. 001, Series of 2022 relative to the Transmittal No. 35, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated June 15, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) represented by its Regional Director, Ms. Cynthia L. Perdiz, Department of the Interior and Local Government (DILG) represented by its Regional Director, Atty. Anthony C. Nuyda, CESO III, and the

Provincial Government of Sorsogon represented by its Governor, Hon. Jose Edwin B. Hamor, relative to the collaboration of the parties in relation to the conduct of Community-Based Monitoring System (CBMS);

WHEREAS, the Community-Based Monitoring System (CBMS) is an organized technology-based system of collecting, processing and validating necessary disaggregated data that may be used for planning, program implementation and impact monitoring at the local level while empowering communities to participate in the process;

WHEREAS, the PSA shall be the lead agency in the implementation of the CBMS pursuant to Republic Act (RA) No. 11315 also known as the CBMS Act;

WHEREAS, Rule VI, Section 7 of the Implementing Rules and Regulations of the CBMS Act tasked the DILG to develop and implement an information and dissemination campaign relating to CBMS, ensure compliance of the LGUs in the various CBMS activities and extend assistance to PSA in the conduct and implementation of the CBMS;

WHEREAS, Section 4 of the CBMS Act provides that each city and municipality is the primary data collecting authority within its locality;

WHEREAS, Section 29 of RA No. 7160, otherwise known as the Local Government Code of 1991, provides that provinces shall ensure that every component city and municipality within its territorial jurisdiction acts within the scope of its prescribed powers and functions;

WHEREAS, Section 305 of the Local Government Code of 1991 provides that local government units shall ensure that their respective budgets incorporate the requirements of their component units and provide for equitable allocation of resources among these component units;

WHEREAS, the Provincial Government of (Province) and its C/MLGUs agree to collaborate with the PSA and DILG to implement CBMS in their locality synchronous with the 2022 CBMS Nationwide Rollout:

NOW THEREFORE, on motion of **Hon. Ma. Theresa S. Gonzalez,** duly seconded by **Hon. Jo Abegail C. Dioneda** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Philippine Statistics Authority (PSA) represented by its Regional Director, Ms. Cynthia L. Perdiz, Department of the Interior and Local Government (DILG) represented by its Regional Director, Atty. Anthony C. Nuyda, CESO III, and the Provincial Government of Sorsogon represented by its Governor, Hon. Jose Edwin B. Hamor, relative to the collaboration of the parties in relation to the conduct of Community-Based Monitoring System (CBMS);

RESOLVED FURTHER, that the Memorandum of Agreement (MOA) entered into by the parties shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;
