RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A CONTRACT OF SERVICE WITH THE ENUMERATORS TASKED TO FACILITATE THE COMPLETION OF THE COMMUNITY-BASED MONITORING SYSTEM (CBMS) IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the July 12, 2022 Regular Session of the 8th City Council is the Committee Report No.001, Series of 2022 relative to the Transmittal No. 37 from the Office of Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated June 22, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Contract of Service with the enumerators tasked to facilitate the completion of the Community-Based Monitoring System (CBMS) in the City of Sorsogon;

WHEREAS, the Contract stipulated the obligation of both parties which are essential for the success of the project;

WHEREAS, the City Government of Sorsogon takes into account the services of the enumerators to conduct Community-Based Monitoring in the Sixty-Four (64) barangays of the City of Sorsogon thus finds hiring of enumerators most advantageous to the government;

WHEREAS, the enumerators have the necessary qualifications and capabilities and have in fact undergone the necessary recruitment evaluation procedures to perform the required services;

WHEREAS, the enumerators are hired on contract basis and shall have the duties and obligations such as to visit and survey all the households in the barangay/area of assignment until completion;

WHEREAS, the City Government of Sorsogon shall pay the enumerators the transportation expenses during the conduct of the survey in the amount of Eighty Pesos (P80.00 per day and the services rendered by them in the amount of Three Hundred Pesos (P300.00) per day for 20 to 25 households surveyed;

WHEREAS, the Contract of Service shall be the period of July 18, 2022 to September 18, 2022 subject to the date stated therein, unless sooner terminated or extended;

WHEREAS, attached to the transmittal is a copy of a draft Contract of Service for further perusal of the 8th City Council;

NOW THEREFORE, on motion of **Hon. Ma. Theresa S. Gonzalez**, duly seconded by **Hon. Jo Abigail C. Dioneda** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Contract of Service with the enumerators tasked to facilitate the completion of the Community-Based Monitoring System (CBMS) in the City of Sorsogon;

RESOLVED FURTHER, that the Contract of Service entered into by the parties shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
