**RESOLUTION FAVORABLY ENDORSING, GRANTING AND CONFERRING EXTENSION OF PERMIT TO OPERATE ELECTRONIC BINGO GAMES TO SALLE DE JEUX, INC., FORMERLY 777 REAL TIME BINGO CORPORATION.**

**WHEREAS**, Salle De Jeux, Inc. was granted by the Sangguniang Panlungsod permit to operate electronic Bingo Games at Vicenta Hall, Fernando's Hotel, N. Pareja St., Barangay Bitano, West District, Sorsogon City for a period of five (5) years reckoning on the date of its approval which is December 6, 2011;

**WHEREAS**, in strict compliance of the aforementioned permit granted, Salle De Jeux, Inc. formerly 777 Real Time Bingo Corporation wrote a letter expressing their intension to continue to operate electronic Bingo Games and further requested that they be granted and conferred extension of permit to operate electronic Bingo Games for another five (5) years;

**WHEREAS**, in view thereof and for purposes of this resolution, the 8<sup>th</sup> City Council hereby favorably endorse, grant and confer extension of Permit to Operate Electronic Bingo Games to Salle de Jeux, Inc formerly 777 Real Time Bingo Corporation for another five (5) years at Vicenta Hall, Fernando's Hotel, N. Pareja St., Barangay Bitan-o, West District, Sorsogon City for a period of five (5) years reckoning on the date of approval of this resolution;
