RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ALLOCATE FUNDS FOR THE PROCUREMENT OF THREE (3) UNITS SERVICE VEHICLE FOR THE MOBILIZATION OF EAST, WEST AND BACON DISTRICT, SORSOGON CITY

**WHEREAS**, the City Government of Sorsogon have only two (2) jeepney service vehicle but are both near to be unserviceable due to its present condition thus, it is main reason for the request of its constituents to purchase vehicles for East, West and Bacon Districts;

**WHEREAS**, the vehicles will be utilized by the constituents to speed up the delivery of the public service in the abovementioned districts;

**WHEREAS**, these will be used as service vehicles for social humanitarian needs in times of emergencies, recue and relief operation during times of calamities and other important activities.

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied there form; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;
