# Resolution No. 044, Series of 2022

RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH THE CITY HUMAN RESOURCE AND MANAGEMENT OFFICE AND THE CITY ACCOUNTANT TO AUTHORIZE THE PAYMENT ON MONTHLY BASIS FOR THE SALARIES AND WAGES OF CONTRACT OF SERVICE AND JOB ORDER PERSONNEL OF THE CITY GOVERNMENT OF **SORSOGON** 

WHEREAS, Civil Service Commission (CSC)-Commission on Audit (COA)-DBM JC No. 1, S. 2017 was issued to provide the rules and regulations regarding the engagement of the services of COS and JO workers in the government;

WHEREAS, In light of the challenges brought about by the COVID-19 pandemic affecting the operations of government agencies, there is a need to update the existing policies on the engagement of COS and JO workers to ensure the smooth, effective, and efficient delivery of services to the public;

**WHEREAS**, Government agencies are authorized to enter into service contracts with other government agencies, private firms, non-government agencies or individuals for services related or incidental to their respective functions and operations, whether on a part-time or full-time basis;

WHEREAS, Contract of Service refers to the engagement of the services of an individual, private firm, other government agency, non-governmental agency or international organization as consultant, learning service provider or technical expert to undertake special project or job within a specific period;

WHEREAS, Job Order refers to piece work (pakyaw) or intermittent or emergency jobs such as clearing of debris on the roads, canals, waterways, etc. after natural/ man-made disasters/occurrences, and other manual/trades and crafts services such as carpentry, plumbing, electrical, and the like;

**WHEREAS**, since the national law and Civil Service Commission prohibit JO workers from receiving bonuses, benefits and allowances like casual and regular employees, the increase in the daily rates of Job Order workers would at least provide them bigger pay amid the economic slowdown caused by the COVID-19 pandemic;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolve, as it is hereby resolved to respectfully request Hon Ma. Ester E. Hamor, City Mayor, Sorsogon City through the City Human Resource and Management Office and the City Accountant to authorize the payment on monthly basis for the salaries and wages of Contract of Service and Job Order Personnel of the City Government of Sorsogon.
