RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO AUTHORIZE THE CITY ENGINEERING OFFICE TO CONDUCT AN INDEPENDENT SURVEILLANCE INSPECTION ON WATER SOURCES AND PROJECTS OF THE SORSOGON CITY WATER DISTRICT AND PRIME WATER INFRASTRUCTURE INC. AND THEREBY ISSUE ITS CORRESPONDING FINDINGS, CONCLUSIONS AND RECOMMENDATIONS IN RELATION THERETO

WHEREAS, the constituents of Sorsogon City that is primarily dependent on the services of Prime Water Infrastructure Inc. as their main water source for their residence/households, however, they repeatedly complaining about poor water services of Prime Water of Sorsogon;

WHEREAS, the water provider of Sorsogon City which is the Prime Water is mandated to provide safe, potable, sufficient, and adequate water thru an efficient delivery system to its consumers in the City of Sorsogon;

WHEREAS, Prime Water started its operation on October 17, 2016 until now, consumers cannot look forward to an improved better service for them;

WHEREAS, complaints of water discoloration such as being muddy, brown color, etc. still exist among its water outlets of Prime Water,

WHEREAS, the Sorsogon Water District together with its joint venture partner, the Prime Water Sorsogon City is committed to fully serve the general public to the best of ability without regards to age, gender, or economic status and shall be committed to uphold the highest standard of public service consistent with its mandate as a public utility to deliver safe, potable, adequate, and affordable water to the consuming public of Sorsogon City;

WHEREAS, the consuming public is continuously experiencing very low water pressure to no water affecting households, businesses, as well as the City government, including national and other agencies of the government operating within the jurisdiction of the City.

WHEREAS, such bad nature of service is documented by the Commission on Audit in its Annual Audit Reports on Sorsogon City Water District (SCWD);

WHEREAS, premises considered, the city government of Sorsogon is constrained to also conduct its independent surveillance inspection on water resources and projects of Sorsogon City Water District and Prime Water Infrastructure Inc. and issue its findings, conclusions and recommendations for the benefit of the general public;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to authorize the City Engineering Office to conduct an independent surveillance inspection on water sources and projects of the Sorsogon City Water District and Prime Water Infrastructure Inc. and thereby issue its corresponding findings, conclusions and recommendations in relation thereto.
