RESOLUTION MOST RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PROVIDE ADDITIONAL FINANCIAL ASSISTANCE AND OTHER BENEFITS OR HAZARD PAY TO THE MEMBERS OF BANTAY DAGAT (SEA PATROL) WHO DISCHARGE THEIR TASKS AT NIGHT-TIME)

WHEREAS, there had been information that some members of the bantay dagat are engaged to perform their task at night-time in the territorial waters of Sorsogon City;

WHEREAS, consistent with RA 8550 otherwise known as the Philippine Fisheries Code as amended, RESOLUTION ENACTING AN ORDINANCE PROVIDING FOR MANAGEMENT, CONSERVATION, DEVELOPMENT, PROTECTION, UTILIZATION AND DISPOSITION OF ALL FISH AND FISHERY/ ACQUATIC RESOURCES WITH THE CITY WATERS OF SORSOGON CITY, AND FOR OTHER PURPOSES. (Author: Hon Nestor J. Baldon), and Resolution NO. 003, Series of 2022 entitled the resolution respectfully requesting Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to consider re-structuring and reorganization of the personnel of the Bantay Dagat Task Force (Author: Hon.

Danilo A. Deladia (Co-authors Hon. Nestor J. Baldon and Hon. Ma. Teresa Perdigon). It is admitted that all these legislations are intended to effectively manage the country's aquatic and marine resources from further destruction;

WHEREAS, the preceding measures likewise emphasized fishing as a source of livelihood of the fisher-folk and the future generation who belong to the marginalized sector and the less privileged.

WHEREAS, it is a true that Bantay Dagat members who are obliged to comply with their duties at night are more exposed to the perils of the sea and other hazards particularly during actual apprehension of the offenders engaged in illegal fishing or otherwise are committing other infractions of existing laws, rules and regulations.

NOW THEREFORE, on motion of **Hon. Bryan J. Pingul**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to most respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to provide additional financial assistance and other benefits or hazard pay to the members of Bantay Dagat (Sea Patrol) who do their tasks at night-time.
