RESOLUTION NO. 02-2022 ENTITLED" A RESOLUTION REQUESTING REMUNERATION IN THE FORM OF HONORARIUM/FINANCIAL ASSISTANCE FOR THE CHAIRPERSONS OF BARANGAY AGRARIAN REFORM COUNCIL (BARC) OF THE FIFTY FOUR (54) BARANGAYS IN THE CITY OF SORSOGON THROUGH THE LIGA NG MGA BARANGAY, HEADED BY HON. BESSIE C. DIAZ AND HUMBL Y ASKING THE SUPPORT OF THE HON. CITY MAYOR MA. ESTER E. HAMOR, HON. CITY VICE MAYOR MARK ERIC C. DIONEDA AND THE MEMBERS OF THE CITY COUNCIL FOR THE PURPOSE

WHEREAS, the Sangguniang Panlungsod is in receipt of the said BARC Resolution No.02-2022 on March 2022 and was subsequently referred to the Committee on Budget, Finance & Appropriations;

WHEREAS, the Sorsogon City Barangay Agrarian Reform Council (BARC) Federation, Inc. is composed of twenty six (26) from East and West Districts and twenty eight (28) from Bacon District for a total of fifty four (54) Barangay Agrarian Reform Councils duly registered with the Securities and Exchange Commission (SEC) under Company Registration NO. CN201639233;

WHEREAS, BARC is a local, multi-sectoral implementing body for agrarian reform program composed of private sector and government representatives;

WHEREAS, the functions of BARC is to effect and facilitate the land transfer program in the community, it shall also be responsible for the mediation, conciliation or arbitration of agrarian conflicts and issues brought to it for resolution and to assist the government in the effective implementation of the plans and programs of the CARP;

WHEREAS, the City Government of Sorsogon through its City Special Programs, Projects and activities is continuously undertaking its support to the peace, order and protective program , peace, order and protective services, one of which is the assistance to Barangay Agrarian Reform Committee (BARC) hence, certain and indispensable undertakings;

WHEREAS, Article XIII, Section 5 of the 1987 Constitution provides that the state shall recognize the rights of the farmers, farmworkers and the landowners, as well as cooperatives and other independent farmers' organizations to participate in the planning, organization and management of the program;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Bessie C. Diaz**, resolved as it is hereby resolve to favorably endorse Sorsogon City Barangay Agrarian Reform Council (BARC) Federation, Inc. Resolution No. 02-2022 entitled "A Resolution Requesting Remuneration in the form of honorarium/financial assistance for the chairpersons of barangay agrarian reform council (BARC) of the fifty four (54) barangays in the City Of Sorsogon through the liga ng mga barangay, headed by Hon.
