RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SOCIAL SECURITY SYSTEM (SSS) REPRESENTED BY MS. ELENITA S. SAMBLERO, DIVISION HEAD RELATIVE TO THE COVERAGE OF THE CITY GOVERNMENT OF SORSOGON'S CONTRACT OF SERVICE (COS) AND JOB ORDER (JO) EMPLOYEES UNDER THEIR SELF – EMPLOYED PROGRAM.

WHEREAS, among the items deliberated during the July 05, 2022 Regular Session of the 7th City Council is the Transmittal No. 36, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated June 14, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Social Security System (SSS) represented by Ms. Elenita S. Samblero, Division Head relative to the coverage of the City Government of Sorsogon's Contract of Service (COS) and Job Order (JO) employees under their Self – Employed Program;

WHEREAS, the SSS is mandated by law to provide social security protection to all self-employed persons and other qualified Filipino workers regardless of trade, business or occupation against the hazards of disability, sickness, maternity, old age, death and other contingencies;

WHEREAS, Sec. 9-A of Republic Act No. 11999 or the Social Security Act of 2018, requires the coverage in the SSS as compulsory for all self-employed persons;

WHEREAS, the SSS Self-Employed Program may be made applicable to the Contract of Service (COS) and Job Order (JO) in a **“Voluntary basis”** of contribution but not coverable under the Government Service Insurance System (GSIS) Law for such personnel to have protection against the hazards of disability, sickness, maternity, old age, death and other contingencies that the SSS offers;

WHEREAS, attached to the transmittal is a copy of a draft Memorandum of Agreement (MOA) for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Reynaldo C. Taladtad**, duly seconded by **Hon. Nestor J. Baldon** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Social Security System (SSS) represented by Ms. Elenita S. Samblero, Division Head relative to the coverage of the City Government of Sorsogon’s Contract of Service (COS) and Job Order (JO) employees under their Self – Employed Program;

RESOLVED FURTHER, that the Memorandum of Agreement (MOA) entered into by the parties shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
