RESOLUTION CALLING ALL CIVIL SOCIETY ORGANIZATIONS TO ACCREDIT WITH THE CITY GOVERNMENT OF SORSOGON IN CONSONANCE WITH MEMORANDUM CIRCULAR NO. 083-2022 DATED JUNE 15, 2022 FROM THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG).

WHEREAS, relevant provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that;

Section 34. Role of People's and Non-governmental Organizations. - Local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy.

Section 35. Linkages with People's and Non-governmental Organizations. - Local government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises

designed to improve productivity and income, diversity agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

Section 36. Assistance to People's and Non-governmental Organizations. - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 083-2022 prescribing Guidelines on the Accreditation Civil Society and Selection of Representatives of the Local Special Bodies;

WHEREAS, for purposes of compliance of the aforementioned memorandum circular, the 8th City Council through the Committee on Livelihood, Cooperatives and Marginalized Sector hereby calls and encourage Civil Society Organizations to accredit with the City Government of Sorsogon;

NOW THEREFORE, on incidental motion of **City Councilor Angelu Magda P. Ravanilla** duly seconded by **City Councilor Danilo A. Deladia**, resolve as it is hereby resolved to call all Civil Society Organizations to accredit with the City Government of Sorsogon in consonance with Memorandum Circular No. 083-2022 dated June 15, 2022 from the Department of the Interior and Local Government (DILG);

RESOLVED FURTHER, that close coordination with Mr. Ramil Marianito, designated Civil Society Organization Desk Officer and Ms. Mabel Morano, LGOO VI, DILG be initiated for purposes of implementation Memorandum Circular No. 2022-083;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information, guidance and most appropriate action.
