RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION OF MR. RICKY DINGLASAN, PROPRIETOR, DINGLASAN GASOLINE STATION AT BARANGAY SAN ROQUE, BACON DISTRICT, SORSOGON CITY.

WHEREAS, records from the Office of the secretary to the Sangguniang Panlungsod revealed that Mr. Ricky L. Dinglasan, Proprietor, Dinglasan Gasoline Station has a pending request filed before the Sangguniang Panlungsod seeking for the passage of a resolution interposing no objection on his proposed business endeavor;

WHEREAS, during committee hearing conducted by the Committees on Energy and Land Use, the applicant was instructed to comply with mandatory requirements imposed by appropriate local and national government agencies;

WHEREAS, in consonance with the principle of free trade and in order to protect the interest of the general constituents against the dangers of “bote-bote system” of selling of petroleum products, the 8th City Council, through the Chairman’s Committee Report of the

Committee on Public Order and Safety of the 8th City Council, hereby adopts and approves the recommendation for the passage of a resolution interposing no objection for the aforementioned application;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution interposing no objection on the application of Mr. Ricky L. Dinglasan, Proprietor, Dinglasan Gasoline Station to operate a Portable Gas Refilling Machine at Barangay San Roque, Bacon District, Sorsogon City;
