RESOLUTION REQUESTING THE 64 PUNONG BARANGAYS IN THE CITY OF SORSOGON TO IDENTIFY CITY PROPERTY LOTS IN THEIR RESPECTIVE BARANGAYS

WHEREAS, in order to support the manifestations made by the Hon. Jo Abegail C. Dioneda relative to the identification of city property lots in the City of Sorsogon that will be used for the intensification of agricultural related programs and projects of the City Government of Sorsogon;

WHEREAS, Punong Barangays as the chief executive of the barangay government and viewed as the village elders will contribute more to the easy identification and recognition of the city government property in their territorial jurisdiction;

WHEREAS, as such, the City Government of Sorsogon through the City Agriculturist Office will be in attaining its goal of a hundred percent implementation of the programs and projects under the Ten Points Agenda program of the City Mayor;

WHEREAS, in support to the effort of the City Government in the inventory of all of its real properties that are necessary for developmental planning and for other purposes;

WHEREAS, every local government unit shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, **enhance economic prosperity** and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;
