RESOLUTION DESIGNATING THE HON. MA. ESTER E. HAMOR, CITY MAYOR AND MS. MAGDALENA D. PALADIN, CITY TREASURER AS THE PRINCIPAL SIGNATORIES IN RELATION TO BANK TRANSACTIONS FOR THE HEREUNDER MENTIONED ACCOUNTS OF THE CITY GOVERNMENT OF SORSOGON WITH THE LAND BANK OF THE PHILIPPINES (LBP), AND DEVELOPMENT BANK OF THE PHILIPPINES (DBP) AND HON. MARK ERIC C. DIONEDA, CITY VICE MAYOR AND MS. MAGDALENA D. PALADIN, CITY TREASURER AS THE ALTERNATE SIGNATORIES OR ATTY. MARK GERALD D. GUIRINDOLA, CITY ADMINISTRATOR AND MS. MAGDALENA D. PALADIN, CITY TREASURER; AND FURTHER DESIGNATING HON. JO ABEGAIL C. DIONEDA AND MS. MAGDALENA D. PALADIN, CITY TREASURER AS THE ALTERNATE SIGNATORIES DURING THE OFFICIAL LEAVE AND/OR TRAVEL OF THE CITY VICE MAYOR

WHEREAS, Sec. 46 of the Local Government Code of 1991 provides that when the governor, city or municipal Mayor, or punong barangay is temporarily incapacitated to perform his duties for physical or legal reasons such as, but not limited to, leave of absence, travel abroad, and suspension from office, the Vice Governor, City or Municipal Vice mayor, or the highest

ranking sangguniang barangay member shall automatically exercise the powers and perform the duties and functions of the local chief executive concerned, except the power to appoint, suspend, or dismiss employees which can only be exercised if the period of temporary incapacity exceeds thirty (30) working days;

WHEREAS, Sec. 4 of Rule III of the omnibus rules of procedure of the 8th Sangguniang Panlungsod of the City of Sorsogon, provides that in the event of the inability of the Vice-Mayor, as presiding officer, to preside at the Sangguniang Panlungsod session, the members present and constituting a quorum thereof shall elect from among themselves a temporary presiding officer, EXCEPT, when an acting Vice Mayor is officially appointed or designated, in which case, he shall automatically act as the acting presiding officer;

WHEREAS, under the Local Government Code of 1991, the Acting Vice Mayor, can perform all the duties and powers pertaining to the Office of the City Vice Mayor as head of the Legislative Department;

WHEREAS, one of which includes the authority to sign pertinent documents relative to the transactions of the City Government of Sorsogon to wit;

D. Paladin, City Treasurer as the alternate signatories during the official leave and/or travel of the City Vice Mayor;
