RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE TO DESIGN AND INSTITUTIONALIZE A COMPREHENSIVE LIVELIHOOD PROGRAMS FOR THE WOMEN'S SECTOR IN THE CITY OF SORSOGON

WHEREAS, it is the policy of the City Government of Sorsogon to ensure that both women and men, boys and girls benefit equally and participate in the development programs and projects of its various departments and ensure the full participation and involvement of both men and women in the development process;

WHEREAS, any development effort of the city government should consider the rights of women, enhance women's full potentials, uplift their status, and lead to the improvement of the quality of their lives, their families and communities;

WHEREAS, the City Government of Sorsogon shall pursue and implement vigorously gender-responsive development policies, designs and integrate specific gender, support systems, take into consideration women and girls rights particularly to economic survival, adopt and implement measures to protect and promote their rights and ensure the widest participation of women in the local government;

WHEREAS, Section 7 of City Ordinance No. 007, Series of 2014, otherwise known as the Sorsogon City Gender Equality and Development (GEAD) Code provides that departments and agencies in the city of Sorsogon engaged in socio-economic programs shall increase their capital assistance and/or subsidy to women with projects geared towards economic sufficiency;

WHEREAS, Section 11 of the same code further provides that the city government through the City Gender Equality and Development Council (CGAD) shall allocate not less than Thirty percent (30%) of the annual GAD fund and proceeds from any other GAD foreign funding for the establishment of livelihood and training centers as well as implementation of capability building programs, projects and activities;

WHEREAS, Section 13 thereof states that the city government of Sorsogon shall promote and support Small and Medium Enterprise (SME) ensuring food and livelihood security for rural as well as urban women utilizing environment and women-friendly and appropriate technology and Section 14 provides that the City Agriculture Office, in coordination with the Department of Science and Technology (DOST) and other line agencies, shall establish a science and women-friendly alternative technology center for urban and rural women in each city/municipality.

WHEREAS, premises considered, it is therefore appropriate, just and proper to design and institutionalize a comprehensive livelihood programs for the women's sector in the city of Sorsogon;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City through the City Social Welfare and Development Office to design and institutionalize a comprehensive livelihood programs for the women's sector in the city of Sorsogon.


RESOLVED FURTHER, that copies of this resolution be furnished to the herein mentioned financial institutions for their information and guidance.
