RESOLUTION RESPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY THROUGH MR. ARNEL H. ANCHINGES, SK 3 HEAD, TO ASSIGN AND DESIGNATE TRAFFIC ENFORCERS AT THE INTERSECTION ALONG THE SORSOGON CITY COASTAL ROAD LOCATED AT BARANGAY CAMBULAGA, WEST DISTRICT, SORSOGON CITY

WHEREAS, every year, an estimated 1.2 million die and over 50 million are injured in road accidents across the world, with around 85% of these numbers coming from low- and middle-income countries;

WHEREAS, in 2011, the Philippines, through the Department of Transportation (DOTr), developed the Philippine Road Safety Action Plan (PRSAP) 2011 to 2020, with the goal of reducing the number of road accidents in the Philippines by 50% by 2020;

WHEREAS, by the opening of the coastal road connecting Barangay Pangpang to Rompeolas, an intersection at Barangay Cambulaga was also established to cater more accessible roads for the public;

WHEREAS, it was observed and many of the motorists traversing the intersection at Barangay Cambulaga in going to either Barangay Pangpang or to Rompeolas caught in surprise while driving along the area that may cause traffic accidents, due to lack of manpower managing the traffic in the absence of traffic warnings, instructions and signages thereat;

WHEREAS, designation of traffic enforcers in the absence of road and traffic warnings, instructions and signages in the said area is necessary to avoid future and imminent danger to lives and properties of our constituents;

WHEREAS, in order to avoid road accidents in the city of Sorsogon and/or minimize their severity, there is a need to designate traffic enforcers in the absence of sufficient warnings on roads by installing appropriate road and traffic signages within its territorial jurisdiction;

NOW THEREFORE, on motion of **Hon. Ma. Teresa D. Perdigon** duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to respectfully request Hon. City Mayor Ma. Ester E. Hamor through Mr. Arnel H. Anchinges, SK 3 Head, to assign and designate traffic enforcers at the intersection along the Sorsogon City Coastal Road located at Barangay Cambulaga, West District, Sorsogon City.

RESOLVED FURTHER, that copies of this resolution be furnished to the herein mentioned financial institutions for their information and guidance.
