RESOLUTION RESPECTFULLY REQUESTING THE MANAGEMENT OF SORECO II TO INTENSIFY THEIR INFORMATION DISSEMINATION CAMPAIGN IN RELATION TO THE IMPOSITION OF 30% MARKED UP RATE FOR TEMPORARY POWER CONNECTION

WHEREAS, the Sangguniang Panlungsod was in receipt of complaints and reports of sudden increase in SORECO II billing statements of the member consumers and the same issue had been posted and discussed elsewhere in social media;

WHEREAS, it is noteworthy to underscore that during July 26, 2022 Regular Session of the 8th City Council, personnel from SORECO II manifested that at least 10% of the total member-consumers is paying the 30% marked up rate being with temporary power connection;

WHEREAS, during the said session, the Building Official of the city government of Sorsogon estimated 30-40% of their applicants failed to submit complete documentary requirements for the issuance of Certificate of Final Electrical Inspection (CFEI) and therefore under temporary power connection with the SORECO II;

WHEREAS, the 8th City Council presumed that there are more residential houses in the city and all covered areas of SORECO II which are in temporary power connection, particularly in rural barangays which are unaware of the imposition of 30% marked up for temporary power connection;

WHEREAS, premises considered, intensified information dissemination campaign in all platforms is of great help to the consuming public for them to be aware of the 30% marked up for temporary power connection and be advised to finally settle the same for their economic advantage;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to respectfully request the management of SORECO II to intensify their information dissemination campaign in relation to the imposition of 30% marked up rate for temporary power connection.

RESOLVED FURTHER, that copies of this resolution be furnished to the herein mentioned financial institutions for their information and guidance.
