RESOLUTION MOST RESPECTFULLY REQUESTING THE PHILIPPINE NATIONAL POLICE (PNP) SORSOGON CITY AND THE SK₃ THRU MR. ARNEL H. ANCHINGES FOR AN EXPLANATION THE PREVAILING INDISCRIMINATE PARKING OF VEHICLES FRONTING SORSOGON COMMERCIAL ESTABLISHMENT AND AT THE INTERSECTION OF BACON ROAD AND ESCUDERO HIGHWAY

WHEREAS, former City Councilor Franco Eric O. Ravanilla sponsored Resolution No. 008, Series of 2020 entitled “Resolution enacting an ordinance prescribing rules and regulations on the proper usage of four-lane national highway within the territorial jurisdiction of the City of Sorsogon and providing penalties for the violation thereof or the “Sorsogon City National Highway Regulation Ordinance of 2019”.

WHEREAS, while the road expansion project of the national government aims to provide a wider and safer road network for the growing number vehicles plying the highways, its improper utilization defeats the noble intention of the concerned entity;

WHEREAS, it is a common and daily sight ten wheeler delivery trucks loaded with construction materials are indiscriminately parked in front of SORCOM and passenger buses at the corner of Escudero Highway and Bacon Road including tricycles;

WHEREAS, there were reported accidents in the area which occurred in broad day light and more often at night for failure of the drivers to use EWD aggravated by the actual location of parking which is the curb of the highway;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution requesting the PNP Sorsogon City and the SK3 thru Mr. Arnel H. Anchinges for an explanation the prevailing indiscriminate parking of vehicles fronting sorsogon commercial establishment and at the intersection of Bacon road and Escudero Highway;

NOW THEREFORE, on motion of **City Councilor Bryan J. Pingul** duly seconded by **City Councilor Nestor J. Baldon**, resolve as it is hereby resolved to respectfully request the PNP Sorsogon City and the SK3 thru Mr. Arnel H. Anchinges for an explanation the prevailing indiscriminate parking of vehicles fronting sorsogon commercial establishment and at the intersection of Bacon road and Escudero Highway;

RESOLVED FURTHER that copy of the written report be submitted to the Chairman of the Committee on Peace, Public Order and Safety for perusal;
