RESOLUTION RESPECTFULLY REQUESTING THE SORECO II MANAGEMENT TO INCLUDE IN THE GENERAL ASSEMBLY MEETING THE POSSIBILITY OF RESCINDING PISO PARA SA TUGANG PROGRAM

WHEREAS, *Piso Para sa Tugang* is a form of death benefit being extended to the bereaved family of a Member Consumer of SORECO II;

WHEREAS, at times, said death benefit becomes a celebrated issue especially when the amount being extended to the next of kin varies thereby creating doubts as regards to its implementation;

WHEREAS, representatives from SORECO II when invited by the 8th City Council may have presented reasons for the disparity in the amount released, however, the fact remains that such program becomes an added burden to the Member Consumers for reasons that an amount is being added to the monthly billing statements of Member Consumers aside from the long list of charges as therein reflected;

WHEREAS, said added burden makes our Member Consumer more susceptible and vulnerable to financial constraints following the unprecedented increases in price of electricity in the Electricity Spot Market;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution respectfully requesting the SORECO II Management to include in the General Assembly Meeting the possibility of rescinding Piso Para sa Tugang Program;

NOW THEREFORE, on motion of **Hon. Danilo A. Deladia** duly seconded by **Hon. Jo Abegail C. Dioneda** resolve as it is hereby resolved to respectfully request the SORECO II Management to include in the General Assembly Meeting the possibility of rescinding Piso Para sa Tugang Program;

RESOLVED FURTHER, that this resolution intends to present the Piso Para sa Tugang Program and its financial status before the next General Assembly of SORECO II Member Consumers;

RESOLVED FINALLY, that copies of this resolution be furnished to SORECO II Management and National Electrification Administration (NEA) for their information and guidance.
