RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A NON – DISCLOSURE AND CONFIDENTIALITY AGREEMENT BY AND AMONG THE CITY GOVERNMENT OF SORSOGON, THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGIONAL OFFICE 5, AND THE DESIGNATED EARLY CHILDHOOD CARE AND DEVELOPMENT – INFORMATION SYSTEM (ECCD – IS) RELATIVE TO THE EARLY CHILDHOOD CARE AND DEVELOPMENT – INFORMATION SYSTEM (ECCD – IS).

WHEREAS, among the items deliberated during the August 09, 2022 Regular Session of the 8th City Council is Transmittal No. 45, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated July 29, 2022, requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Non – Disclosure and Confidentiality Agreement by and among the City Government of Sorsogon, the Department of Social Welfare and Development Regional Office 5, and Early

Childhood Care and Development – Information System (ECCD – IS) relative to the Early Childhood Care and Development – Information System (ECCD – IS);

WHEREAS, for the purpose of preventing the unauthorized disclosure of Personal Data and Information in line with the provisions of Republic Act (R.A.) 10173, otherwise known as The Data Privacy Act of 2012, and its implementing Rules and Regulations (IRR), the Parties hereby agree to enter into a confidential relationship with respect to the disclosure of Personal Data/Information in the Early Childhood Care and Development – Information System (ECCD-IS);

WHEREAS, all Divisions and Units of the DSWD-Field Office shall utilize the regional level information to monitor and assess the implementation of ECCD and other related programs such as but not limited to the Supplementary Feeding Program particularly in monitoring children with cases on severely underweight and overweight at their respective locality;

WHEREAS, attached to the letter is a copy of a Non – Disclosure and Confidentiality Agreement for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Bryan J. Pingul** resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Non – Disclosure and Confidentiality Agreement by and among the City Government of Sorsogon, the Department of Social Welfare and Development Regional Office 5, and Early Childhood Care and Development – Information System (ECCD – IS) relative to the Early Childhood Care and Development – Information System (ECCD – IS);

RESOLVED FURTHER, that the Non – Disclosure and Confidentiality Agreement entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;
